Easy Fish Cakes

1 pound fresh skinless, boneless cod fillet
2 tablespoons olive oil
1 large egg, lightly beaten
1/4 cup thinly sliced scallions
2 tablespoons mayonnaise
1 tablespoon freshly squeezed lemon juice
2 tablespoons Dijon mustard
6 tablespoons breadcrumbs
3 tablespoons chopped fresh parsley
3 dashes hot sauce, such as Tabasco
Coarse salt and freshly ground pepper
Tartar Sauce

Preheat the oven to 400 °F. Rub cod with 1 tablespoon oil & place in a baking dish. Roast until cooked through. Let cool & pat dry with paper towels. Flake with a fork. In a large bowl, combine cod with all ingredients but tartar sauce until ingredients just hold together into eight equal-size patties. Heat 1 tablespoon oil in a large nonstick skillet over medium heat. Cook cakes until golden brown, about 2 minutes on each side. Serve hot with tartar sauce.

Trout Committee

On Sunday May 24th TRAA members released approximately 35,000 brown trout into Oxbow Creek on Eva Bright's property. We had a great turnout. The Trout Committee would like to thank all those who came to help out at the release.

The trout hatchery remains active with our rainbow trout. They have been moved into the circular tank and are feeding like crazy. They are now at a point when they will also need to be released. The release date will be either be June 16th or June 17th. A firm date will be decided upon at the June 13th General Meeting. The donor creek, Dingman's Creek, has already been chosen. If you are wondering about the choices for these donor streams (Oxbow & Digman) come out to the meeting for an explanation.

Those members who are visiting the trout hatchery already know that the valve and associated plumbing for the circular is not in good shape. It cannot be addressed until the rainbows have been released, because we are concerned about the use of solvents while there are fish in the hatchery system. We will be planning a couple of work parties to do a complete retrofit on all the plumbing in the right from the source intake, into the hatchery enclosure and throughout all of the systems within the hatchery. We'll need lots of help to do this so come to the June 13th General Meeting for the dates and details.
